Notice to clubs to re-Affiliate for 2024/25

To reaffiliate with CACTMC, a Club must complete and submit the following by **10 June 2024**:

- 1. **CACTMC Affiliation Form** (page 2 of this pack);
- 2. Pay the Affiliation Fee as set out below under "Payments to CACTMC".
- 3. Evidence of the Club's ongoing **Incorporation** or Company registration:
- (e.g. An *Extract* from the *Register of Incorporated Associations* showing incorporation status and date).

If the club is authorized to endorse **Concessional Registration Scheme (CRS)** applications, the club MUST also complete and submit the following sets of documents – also by June 10:

- 4. Lists of ACT CRS (V,V,H & Mod) and NSW HVS & CVS vehicles that are endorsed by the Club;
- 5. ACT Concessional Registration Scheme Authorised Club Signatories form. (see page 7)

Note: The CACTMC Affiliation form, List of Endorsed Vehicles (ACT CRS and NSW HVS & CVS), Authorised Club Signatories form, and documentary evidence of Incorporation, should <u>ALL</u> be submitted by email to: <u>Secretary@CACTMC.org.au</u> or handed to the *Secretary* at a CACTMC General Meeting.

Please ensure that the forms and the text are clear and legible. (Photos of the forms will generally NOT suffice!) The **List of Endorsed Vehicles** may be submitted as a **spreadsheet**, provided the data is presented in the same format. *A template for the endorsed vehicle data spreadsheet can be downloaded <u>HERE</u>.*

Regardless of the method of delivery, these <u>documents must ALL be received</u> by the Secretary **by 10 June 2024**. If the documents are provided after this date, they may not be able to be processed and uploaded into the Access Canberra system in time for the new financial year, which may delay the reregistration of a Club's CRS vehicles.

Carbon Offset Program

CACTMC is again providing its affiliated Clubs the opportunity to make a voluntary donation to the **CACTMC Carbon Offset Project** to assuage the impact of greenhouse gasses generated by Clubs' concessionally registered vehicles. To participate, please add the suggested, or other, amount to your Club's Affiliation Fee payment. The donated funds will be provided to an authorized local organisation that undertakes accredited land sector abatement projects: e.g. reafforestation, revegetation, land care management, etc.

The **annual Affiliation Fee** is dependent on the number of current club members according to the schedule:

Number of Club Members	Annual Fee	Carbon Offset	Total
1 to 49	\$40	\$10	\$50
50 to 149	\$75	\$20	\$95
150 or more	\$200	\$40	\$240

IMPORTANT NOTE for clubs with CRS, HVS & CVS endorsed vehicles

Affiliation with CACTMC requires a club to submit the above forms **AND** pay the annual Affiliation Fee by **10 June**. Failure by a club to submit reaffiliation documents by the due date, risks rendering all vehicles endorsed by that club for CRS, HVS & CVS, ineligible for use under the concessional/conditional registration schemes of ACT & NSW.
