Incorporation Reminder

Council of ACT Motor Clubs' Affiliated Clubs are reminded that incorporation becomes a mandatory requirement for Affiliation after 30 June 2023. Clubs that are not incorporated beyond this date will cease to be affiliated and their members will consequently lose access to Concessional Registration.

Please ensure that proof of your Club's incorporation is lodged with the Secretary prior to 30 June 2023.

Re affiliation reminder

Clubs are reminded that re-affiliation with the Council of ACT Motor Clubs is due not later than June 30 2023. The 2023-24 Reaffiliation forms will be available on the web in March.

Clubs are also reminded that the payment of affiliation fees is to be done by Electronic Funds Transfer (EFT) or direct deposit into the CACTMC account. Council's auditing requirements preclude payment by cheque or cash.

Club Stamp required for NSW HVS & CVS registrations

Clubs that have members who have vehicles registered in NSW through the Historic Vehicle Scheme (HVS) or the Classic Vehicle Scheme (CVS) please be advised that the NSW registering authority now requires all NSW conditional registration applications, or renewals, to carry the imprint of the endorsing Club's official **club stamp**. NB: This is NOT the stamp issued to Clubs by Council for ACT's CRS registrations/renewals.

Club registrars to attend meeting.

Council Registrar, Dave Rogers, has advised that a meeting of all Club Registrars, or their nominated representative, will be held to discuss the introduction of the new 60-day usage scheme as it effects CRS registered vehicles.

It is vitally important that all Clubs with CRS registered vehicles should attend this meeting.
