**The Council of ACT Motor Clubs cordially invites your participation at
Wheels 2025 at the Queanbeyan Showgrounds on Sunday 16th February**

Wheels is the [Council of ACT Motor Clubs](https://cactmc.org.au)' (CACTMC) annual heritage motoring enthusiasts' display.

2025 marks the 44th occasion of this prestigious event which this year is generously sponsored by **Famous Insurance Brokers**. The event will be held in the main **Arena** of the **Queanbeyan Showgrounds**.

Wheels is open to all marques and is attended by many motoring enthusiasts from ACT and regional NSW. This year's featured vehicle category is anything *Famous*. But tell us why its famous.

In recent years there have been approximately 500 vehicles on display, representing most of the major current and former manufacturers from the early 1900s to present day vehicles.

If you have attended Wheels in recent years, you will note that while the layout is similar to the 2024 event, the logistic arrangement (especially the entry method) for the 2025 event is a little different.

A dedicated area is being set aside for automotive trade vendors. This area forms an arc around the perimeter of the Showgrounds Arena and is immediately in front of the Grandstand. The individual vendor sites face towards the centre of the Arena containing the display of 500 plus exhibitor vehicles. There is also a pedestrian corridor running for the full length of the vendor area, between the vendors and the display of exhibitors' vehicles.

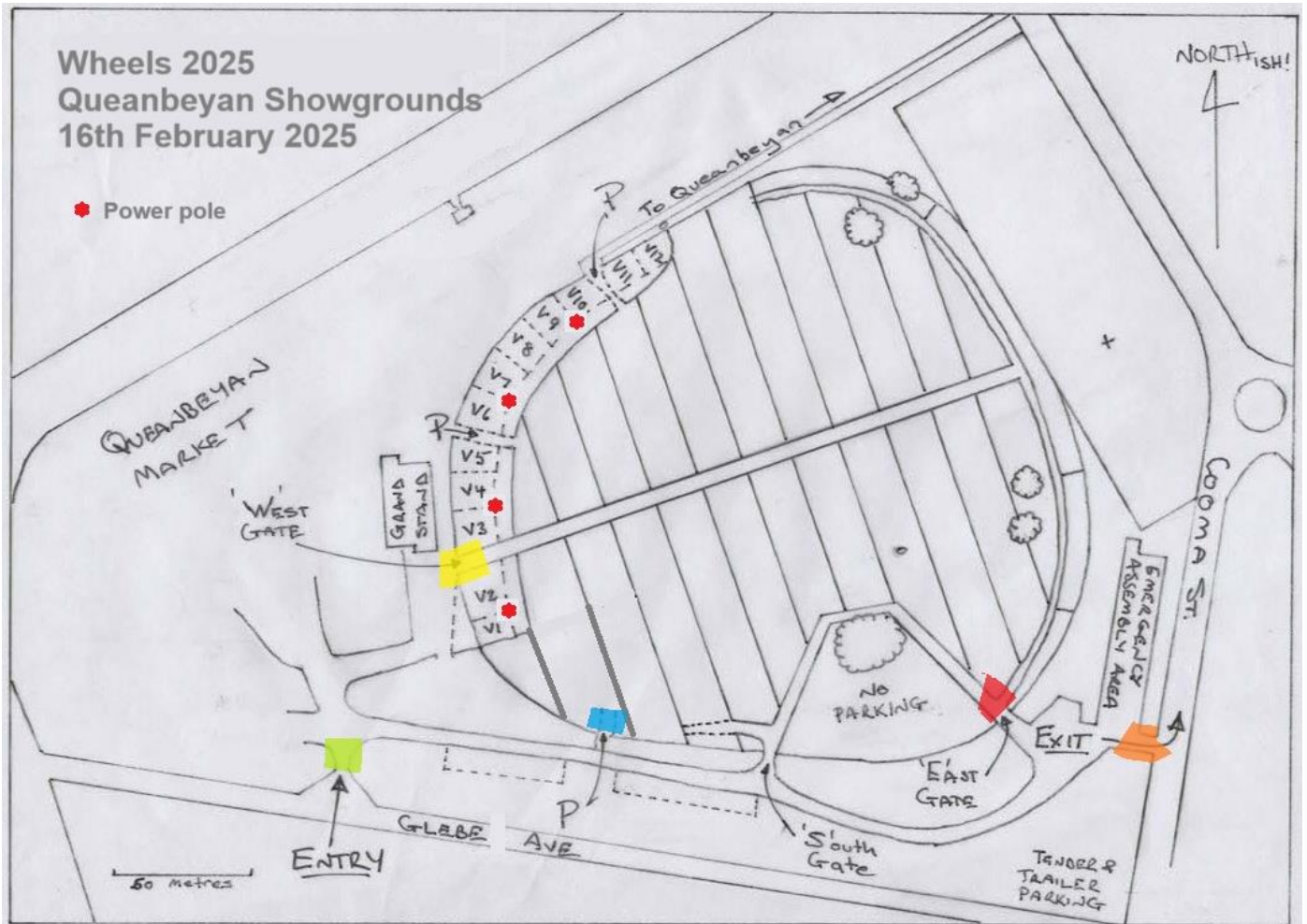
The vendor sites are nominally about 10m x 10m. Most of these sites also have mains power available. If additional space is required, this can be accommodated in most cases, but please discuss with us first.

Access by vendors to the sites would be possible from 7:30am on Sunday 18th February – i.e. the day of the event. Vendors should endeavour to have their site set up by 9:30am at the latest and should remain in place until 2:30pm as the event is open to the public, for pedestrian traffic only, from 10:00am until 1:30pm.

We are offering premium vendor sites for \$150. This could be as a donation, sponsorship or fee, whichever suits your organisation. A tax invoice can be provided.

This year we are again running Wheels in conjunction with the **Queanbeyan Market** (food, non-alcoholic drinks, crafts, jewellery, fashion etc). The Market will be located at the western end of the Showgrounds complex. The combined Wheels & Market event means that it will be an ideal outing for the whole family, with plenty to interest the Mums, Dads and the kids on the day.
